The Italian Mandolin Federation (FMI) and the Town of Ala announce **the 5th International Competition “Giacomo Sartori”**, which will take place *from the 5th to the 7th October 2007* in Ala at the “Giacomo Sartori” theatre.

The competition consists of three categories:

- a) mandolin and guitar duo
- b) quartet/quintet
- c) mandolin orchestra

The decisions of the international jury are definitive and final.

I. To enter the competition, you have to send:

- 1) Application form duly filled-in which must be sent to the secretary's office of the competition **within 31<sup>st</sup> August 2007** (the postmark will confirm the date of sending).
- 2) Curriculum of the group and of the conductor for category c) and of the group and/or of the single performers for categories a) and b).
- 3) Programmes of concerts, critical reviews and any other document competitors think suitable to enclose to the application form.
- 4) Two photos

II. The documentation submitted for admission, which will not be returned in any case, will be examined by the artistic management of the competition.

III. Once selected on the basis of the information provided, all competitors must send **five** copies of the scores of every composition of the free programme **within 10 days** after receipt of the admission confirmation. If the scores are not sent, the performer/group will be excluded from the competition.

IV. The winners of the first prizes at the 4<sup>th</sup> competition “Giacomo Sartori” cannot compete in the same category for the 5<sup>th</sup> edition.

V. Entrance fee:

- mandolin and guitar duo: € 150
- quartet/quintet: € 300
- mandolin orchestra: € 400

In no case the entrance fee will be returned.

**For all categories: the second test by choice has to be only original music (no transcriptions).**

VII. Prizes

Cat. a)

1<sup>st</sup> prize € 1.200

2<sup>nd</sup> prize € 600

3<sup>rd</sup> prize € 300

Cat. b)

1<sup>st</sup> prize € 2.000

2<sup>nd</sup> prize € 1.000

3<sup>rd</sup> prize € 500

Cat c)

1<sup>st</sup> Prize € 2.500

2<sup>nd</sup> Prize € 1.250

3<sup>rd</sup> Prize € 650

The first prize cannot be divided. In particular cases the jury can award as “ex aequo” the remaining prizes. The jury can decide not to award any prizes at all, if the artistic level is not worthy.

A special prize of € 1.000 will be awarded to the best performance of pieces by Giacomo Sartori.

On all prizes fiscal deductions will be applied according to law.

**On Sunday, 7<sup>th</sup> October 2007, at 9 p.m.**, the public concert of the winners will take place in the “Giacomo Sartori” theatre together with the prize giving ceremony. The performance of the winners is compulsory, under penalty of exclusion and loss of the won prizes.

All rehearsals and the final concert are public and will be recorded. Recordings could be duplicated, broadcasted by television and radio and photos may be taken and published, but performers cannot claim any rights for them.

Costs for travelling and stay are at the performers’ expense.

**Entering the competition implies the full acceptance of the present regulations and of further changes, if any.**

**The organising committee reserves itself the right to modify the regulations of the competition.**

Each player and group is fully responsible for his/her/their performance.

**Should any objection arise, only the original Italian text of the regulations will be valid.**

***Information as stated by art. 13 of the Italian Law 196/2003.***

*Personal data are supplied on paper and electronically.*

*If some data are missing, this could involve the non admission to the competition. The data can be used by the Italian Mandolin Federation (FMI), by the Federation of Trentino-South Tyrol (FMTAA) and by the Town of Ala in order to carry out the competition and for informing the media.*

*The involved people have the rights according to art. 7 of the Italian Law 196/2003.*

*The signature of the application form determines the assent to dealing with personal data as stated by art. 23 of the Italian Law 196/2003.*

*The holder of the right of dealing with these data is the Italian Mandolin Federation of Trentino-South Tyrol through its legal representative.*
