*The cultural association "Il Focolare" in cooperation with the FMI announces the fifth "Raffaele Calace" competition - category: Mandolin and Piano. The competition will take place in Pignola (Potenza) on Saturday 23<sup>rd</sup> and Sunday 24<sup>th</sup> August 2008 during the manifestation "E...STATE A PIGNOLA" XIX ed.*

### RULES

#### **Art. 1 ADMISSION**

The competition is open to all mandolinists and pianists of any nationality. The minimum age is 15. (For people who are under age, it is necessary the authorization of the person who has the parental authority).

#### **Art. 2 CONDITIONS OF PARTICIPATION**

The filled application form - downloaded by internet [www.federmandolino.it](http://www.federmandolino.it) – must be sent by registered letter to:

**The closing date is 15<sup>th</sup> June 2008.** The date of the postmark will be considered. The organization reserves the possibility to postpone the closing date.

Besides the application form it's necessary to send:

- a copy of a valid identity paper, signed in original
- curriculum
- list of the pieces to perform
- any other document that the competitor thinks it will be useful.

The presented documents will be examined by the stage manager.

The candidates will be informed of their admission.

### **Art. 3 PROGRAMME**

- a compulsory piece chosen among Raffaele Calace's compositions for mandolin and piano (music of R. Calace sonatas can be downloaded by the web site [www.federmannolino.it](http://www.federmannolino.it)).
- one or more pieces freely chosen from the original repertoire for mandolin and piano (from 1800 to nowadays), for a maximum length of 20 minutes.

**IMPORTANT – When they submit their application form, the candidates have to communicate the chosen programme. The quality of this programme will be taken into account by the jury. At the beginning of the competition the candidates have to give four copies of the scores of all the compositions they intend to perform to the jury, with the exception of the compulsory piece. (these copies will not be given back).**

**An official pianist will be at candidates disposal.**

### **Art. 4 CARRING OUT OF COMPETITION**

All the admitted participants will have to arrive at Pignola within 11 o'clock a. m. **on Saturday 23<sup>rd</sup> August 2008.**

The competition will take place in two times:

- **on Saturday 23<sup>rd</sup> August** in the afternoon: screening test with the performance of the compulsory piece + 5' of the chosen repertoire
- **on Sunday 24<sup>th</sup> August** in the evening: final performance of the first 6 graded and prize-giving.

### **Art. 5 JURY**

The jury is composed by:

A notary will be present too. Without right to vote representatives of the Region, Province and Town Council will be admitted.

Members of the jury must not have any relationship with the candidates.

The organizing committee has the right to substitute with other members chosen by the jury one or more members who haven't got the possibility to take part.

The test of every candidate can be stopped when the jury thinks it's right.

Every member of the jury will express a mark from 1 to 10 (quarters of marks if it's necessary) in a special report card. The average of the marks will determine the final result. In the case of equality the president mark will be decisive.

The judgement of the jury is unappealable.

### **Art. 6 PRIZES AND REIMBURSEMENTS**

First prize: a mandolin of Calace lute-maker's workshop (*Annamaria mandolin, new conception*) + cash-prize (300 euro)

Second prize: euro 400

Third prize: euro 300.

The first prize is indivisible, the other prizes can be assigned ex-aequo. The jury has the faculty not to assign the prizes if any candidate is worthy.

Every participants will receive a certificate with the obtained mark.

The Association "Il Focolare" will offer the participants board and lodging during the days 23<sup>rd</sup> and 24<sup>th</sup> August. Other accompanying people will be given hotel agreements.

**Art. 7 FINAL SHOW, PRIZE-GIVING and THE CONCERT OF THE WINNERS**

The announcement of the winners and the prize-giving will take place in the evening 24<sup>th</sup> August during the show “*E...state a Pignola*”. In the same show a performance of the three winners is required.

**Art. 8 RECORDING RIGHTS**

“*E state a Pignola*” may be recorded. Recordings could be duplicated, broadcasted by television and radio and photos may be taken and published. The participants can claim no rights on this material and authorize the Association “Il Focolare” to make use of it.

**Art. 9 ACCEPTANCE OF THE RULES**

The signature on the application form implies the full acceptance of the present rules. For the clauses not provided in the present rules, the laws in force, as regards the show, are valid.

The organization reserves the possibility to make changes in the rules in order to improve the success of the manifestation, to postpone or to cancel the manifestation for reasons beyond his control.

All participants will take full responsibility of their performance. The organization cannot be held responsible for texts or situations in any way detrimental to morality and religion.

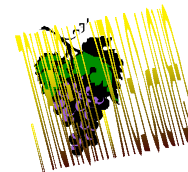
For every controversy the court of Potenza is competent.
